OFFICIAL RULES

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN, NOR WILL A PURCHASE IMPROVE ONE’S CHANCES OF WINNING

1. SPONSOR: Radio Disney, a division of ABC Radio Networks Assets, LLC (Hereinafter referred to as “Sponsor”).

2.
