

**Disney's Muppets Most Wanted Catch Constantine Sweepstakes
Official Rules**

NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCE OF WINNING. Entrants ("Entrant/s") under the age of 18 must have permission from their parent or legal guardian in order to enter.

1. Eligibility

Disney's Muppets Most Wanted Catch Constantine Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) United States (including the District of Columbia), who are at least thirteen (13) years old at the time of entry, with a Instagram account in good standing. Those under the age of majority in their state of residence (a "Minor") must have the permission of their parent or legal guardian in order to be eligible to enter. Void in Guam, Puerto Rico, the U.S. Virgin Islands and other U.S. territories and possessions and where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of ABC, Inc. d/b/a/ Walt Disney Studios Motion Pictures, 500 South Buena Vista Street, Burbank, CA 90051 (the "Sponsor"), Rubik Marketing LLC ("Administrator") or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively, with Sponsor and Administrator, the "Sweepstakes Entities") and their immediate family (spouse, parents and step-parents, siblings and step- siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state, municipal, and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. 2. Sweepstakes Period

The Sweepstakes begins on March 13, 2014 at 9:01:00 AM Pacific Time ("PT") and ends on March 30, 2014 at 11:59:00 PM PST (the "Sweepstakes Period"). The Website (defined below) clock is the official timekeeper for this Sweepstakes.

3. How to Enter

To participate in the Sweepstakes, you must (a) visit the Sweepstakes site on www.disney.com/catchconstantine (the "Sweepstakes Site") and follow the directions to obtain the "Catch Constantine" image in order to take a photo ("Photo") and post on Instagram as further described below; and (b) have the Instagram application on your mobile device and an active Instagram account ("Account"). If you do not have an Account, open the Instagram application on your mobile device and sign up for an Account according to the instructions in the application. Creating an Account is free. Once you have logged into your Account you may enter by posting a Photo of "Constantine" in his hiding place. Each Photo you post must be accompanied by the caption "#CatchConstantineSweeps" during the Sweepstakes Period to constitute one (1) entry ("Entry").

In order for an Entry to be valid, your Account must be public and viewable by the Sponsor (i.e. the "Photos Are Private" option in your Instagram account settings must be set to "OFF.") and your post must include the hashtag "CatchConstantineSweeps" in the caption to your posted Photo.

Posting a Photo on Instagram requires a mobile device and therefore message and data rates may apply. All images with hashtags must include the "Constantine" image provided by Sponsor from the Sweepstakes Site. All incomplete or non-conforming entries will be disqualified.

Limit three (3) Entries total per person during the Sweepstakes Period, regardless of the number of Accounts a person may have. In the event of a dispute as to the identity of the Account holder, Entry will be awarded to the person whose named as the Account holder, provided such individual is eligible according to these Official Rules.

By entering this Sweepstakes, each Entrant agrees that the Sponsor and/or Administrator has the right to contact the Entrant as described herein on Instagram to administer and fulfill this Sweepstakes.

This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with Instagram. Instagram is a registered trademark. Such use is not intended to suggest or imply the sponsorship, endorsement, or the approval of this Sweepstakes by Instagram.

5. Photo Requirements, Restrictions and License

- a) Entrants (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence) agree to and understand that the Photo will be made available to the public, including without limitation, posting on the Internet. Whether or not the Photo is published on the Internet, Sponsor makes no representation or warranty regarding the confidentiality of any Photo.
- b) Each Photo must be taken by Entrant and be an original creation of the submitting Entrant. The Photo must be under no restriction, contractual or otherwise, that will prevent Sponsor's use of the Photo and each Photo must be free of any and all liens, encumbrances and claims of third parties. Entrant (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence) acknowledges, agrees, represents and warrants that, nothing in the Photo infringes on any copyrights, confidential information, trade secrets or trademarks belonging to any person or entity other than the Entrant absent a suitable license, clearance or permission agreement (proof of which may be required upon submission), or violates any person's rights of privacy or publicity and that all necessary releases and permissions have been secured from anyone appearing in the Photo or any person or entity with any rights in or to the Photo. - d) Entrants are responsible for securing necessary permissions, talent and location releases, and licenses for any visual material contained in the Photo.

6. Photo Content Restrictions

Photo must not contain material that:

- a) Contains or depicts someone smoking or intoxicated;
- b) Violates or infringes another's rights, including without limitation, privacy, publicity or intellectual property rights, or that constitutes copyright infringement;
- c) Contains material that promotes bigotry, racism, hatred or harm against any group or individual or promotes discrimination based on race, sex, religion, nationality, disability, sexual orientation or age;
- d) Contains any unacceptable clothing or adornments, or displays any commercial/corporate advertising other than that of Sponsor;
- e) Contains indecent or unsafe behavior or situations, profanities or obscenities, including but not limited to nudity, or pornography, or is otherwise inappropriate, indecent, profane, obscene, hateful, tortuous, slanderous or libelous;
- f) References persons or organizations without their written permission;
- g) Disparages any persons or organizations;
- h) Includes threats to any person, place, business, or group;
- i) Is unlawful, in violation of or contrary to all applicable federal, state, or local laws and regulations; and
- j) Does not comply with the terms or conditions or guidelines posted by Instagram.

Failure of any Photo to comply with the above "Photo Requirements" and "Photo Content Restrictions," as determined by Sponsor, in its sole discretion, may result in disqualification of Entrant. Approximate retail value ("ARV"): \$5,855 which will vary depending upon point of departure and seasonal fluctuation of hotel rates and airfares. 8. Grand Prize Restrictions

withhold delivery of the Grand Prize if winner does not comply with the above requirements and the Grand Prize may be forfeited, in Sponsor's sole discretion, by winner's such noncompliance.

The Sweepstakes Entities make no warranties, and hereby disclaim any and all warranties, express or implied, concerning any prize furnished in connection with the Sweepstakes. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND THE SWEEPSTAKES ENTITIES HEREBY DISCLAIM ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.

9. Winner Selection and Notification

There will be a total of one (1) Grand Prize winner in this Sweepstakes, who will be randomly selected by Administrator from among all eligible entries received throughout the Sweepstakes Period on or about March 31, 2014 ("Drawing Date"). On or about April 1, 2014, Sponsor will notify winner via Instagram Direct or by posting a comment to winner's Entry on Instagram. Upon initial notification by Sponsor, potential winner will need to provide their contact information (email and/or phone number), as requested by Sponsor, as follows: **[a]** if Sponsor notifies potential winner via Instagram Direct, potential winner must respond to Sponsor's Instagram Direct message with their contact information, or **[b]** if Sponsor posts a comment to winner's Entry on Instagram, winner must contact Sponsor at the email address or phone number provided by Sponsor and provide Sponsor with their contact information.

If potential winner is a minor in the state of his/her residence: [a] he/she will need to provide Sponsor with their parent/legal guardian's email address and phone number; and [b] their parent/legal guardian must claim the Grand Prize and the Grand Prize will be awarded in the name of the parent/legal guardian. In the event that no potential winner is verified by April 30, 2014, no alternate winner will be selected and the Prize(s) will not be awarded. **Odds of winning depend on the number of eligible entries received during the Sweepstakes Period.**

10. Verification of Potential Winner

In order to be confirmed as the Grand Prize winner, and without limitation of any other terms herein, the potential winner (or the potential winner's parent/legal guardian if the potential winner is deemed a minor in the state of his/her residence) must provide satisfactory proof, as determined by Administrator in its sole discretion, that such potential winner is an eligible Entrant, including but not limited to providing a copy of the potential winner's government-issued identification and/or additional information required by Sponsor and/or Administrator in order to verify eligibility and compliance with these Official Rules. The potential winner (or winner's parent/legal guardian if the potential winner is deemed a minor in the state of his/her residence)

12. Publicity

Submission of a Photo constitutes Entrant's (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence) certification that the Photo is Entrant's own original work and Entrant (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence). Entrant (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence) hereby agrees not to instigate, support, maintain or authorize any action, claim or lawsuit against Sponsor, or any other person, on the grounds that any use of the Photo as provided herein, infringes any of Entrant's rights as the creator of the Photo as provided herein, including, without limitation, trademark rights, copyrights and moral rights or "droit moral". Except where prohibited, participation in the Sweepstakes constitutes winner's (or winner's parent/legal guardian, if winner is deemed a minor in the state of his/her residence) consent to Sponsor's and its agents' use of winner's name, or Instagram handles, likeness, photograph, voice, opinions and/or hometown and state for promotional purposes in any media, worldwide, in perpetuity, without further payment or consideration.

13. General Conditions

Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, for any reason whatsoever, including, without limitation, fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis, order of any court or jurisdiction or if any fraud, technical failures or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner in a random drawing from all eligible, non-suspect Entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each Entrant's sole and exclusive remedy under such circumstances. Sponsor reserves the right in its sole discretion to disqualify any individual it

finds to be tampering with the entry process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Only the type and quantity of prizes described in these Official Rules will be awarded. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

14. Limitations of Liability

The Released Parties as set forth above are not responsible for: (1) any incorrect or inaccurate information, whether caused by Entrants, printing errors or by any of the equipment or programming associated with or utilized in the Sweepstakes; (2) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (3) unauthorized human intervention in any part of the entry process or the Sweepstakes; (4) technical or human error which may occur in the administration of the Sweepstakes or the processing of entries; or (5) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from Entrant's participation in the Sweepstakes or receipt or use or misuse of any prize. If for any reason an entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, Entrant's sole remedy is another entry in the Sweepstakes, provided that if it is not possible to award another entry due to discontinuance of the Sweepstakes, or any part of it, for any reason, Sponsor, at its discretion, may elect to hold a random drawing from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Entrant further agrees and acknowledges that Sponsor reserves the right to forfeit or award any unclaimed or leftover Grand Prize at its sole discretion.

15. Disputes/Governing Law

Entrant (or Entrant's parent/legal guardian, if Entrant is deemed a minor in the state of his/her residence) agrees that: (i) all disputes, claims and causes of action at law or in equity (individually, "Claim") arising out of or relating to the Sweepstakes, the meaning or interpretation of these Official Rules or the prize awarded shall be resolved by applying the laws of California, without regard to conflict of laws provisions therein, and shall be solely and exclusively brought in the state or federal courts within that state; (ii) all Claims shall be resolved individually, without resort to any form of class action; (iii) all Claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event include attorneys' fees, and under no circumstances will any Entrant be permitted to obtain awards for, and hereby waives all rights to claim, punitive, incidental, special, consequential damages and any other damages, other than for actual out-of-pocket expenses and waives all rights to have damages multiplied or otherwise increased. Notwithstanding the foregoing, Released Parties shall be entitled to seek injunctive relief (unless otherwise precluded by any other provision of these Official Rules) in the state and federal courts of Los Angeles County.
