

## **MEET ROSS LYNCH SWEEPSTAKES OFFICIAL RULES**

### **I. NAME OF SPONSOR**

Radio Disney, a division of ABC Radio Networks Assets, LLC ("Sponsor"), 500 S. Buena Vista St., Burbank, CA 91521, whose decisions are final and binding as to all aspects of this sweepstakes ("Sweepstakes").

### **II. ELIGIBILITY**

The Sweepstakes is open to anyone who is a legal resident of, and physically located within, the 50 United States, the District of Columbia, or Canada (excluding Quebec) ("Territory").

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Sponsor, any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the Sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, immediate family and household members of such individuals and any person who, within the past six months, has been awarded a Grand Prize in any sweepstakes conducted by Sponsor, are all ineligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

### **III. HOW AND WHEN TO ENTER**

#### **NO PURCHASE NECESSARY.**

**On-line Entry:** During the period the two (2) Entry Periods: Entry Period one (1) commencing at 4:00 P.M., November 2, 2012, and ending at 9:00:00 A.M., November 5, 2012; and Entry Period two (2) commencing at 4:00 P.M., November 9, 2012, and ending at 9:00:00 A.M., November 12, 2012 ("Entry Periods"), the Sweepstakes may only be entered On-line by a registered Disney.com guest ("Member"). For purposes of these Official Rules ("Rules"), all times are Pacific Time and "Day" shall mean the period commencing at 4:00:00 P.M. of one day and ending at 3:59:59 P.M. of the next day, except that the last Day shall be 9:00:00 A.M., November 12, 2012. If you are not already a Member, you may easily register to become a Member for free through the link on the site: "Register" by filling out the simple Registration Form. A Member may enter by going directly ("Website"), by clicking on the "Radio Disney Austin and Ally" Link, voting for their favorite N.B.T Artist and "enter" button. Once you have logged in and voted, submission will result in one (1) On-line Entry into the Sweepstakes. You or Your parent/legal guardian ("Parent") will be sent an initial e-mail notification advising you have registered at RadioDisney.com for an On-line Entry into a Radio Disney Sweepstakes, asking to verify this Entry by clicking on a link in the e-mail, validating Entry as described in the e-mail and providing a phone number where you can be reached if his/her child is chosen as a potential winner. After the validation process, you or the child will automatically be able to enter and logging in up to once every day during the Entry Periods. If you do not validate registration and On-line Entry, the Entry will be denied. Normal internet access and usage charges imposed by your online service will apply. It is your sole responsibility to notify Sponsor if you change your e-mail address ("Address"). To do so, go to <http://register.go.com/disney/GuestServices/YourAccount/login>, log into your Membership Account, click on the "Modify" icon and follow the instructions on how to change the Address.

“Entry” shall mean and refer to each On-line Entry.

Entries remain the property of the Sponsor and will not be returned.

All Entries must be received or credited by 9:00:00 A.M., November 12, 2012.

Only one (1) On-line or SMS Entry per entrant per Day is permitted (a maximum of eight (8) Entries per entrant during the Entry Period); per entrant per Day is permitted. However, you are able to vote for your favorite NBT Artist ten (10) times a day but only one (1) Entry is received each Day.

Mass Entries or Entries generated by a script, macro or use of automated methods will be disqualified. If for any reason the Sweepstakes is not capable of running as planned, including infection by computer virus, bugs tampering, unauthorized intervention, fraud, technical failures, or other causes that corrupt or affect the administration, security, fairness, integrity or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes. If canceled, Sponsor reserves the right at its discretion to determine the Winner using all non-suspect eligible Entries received up to the time of cancellation. Sponsor is not responsible for failed, partial or garbled computer transmissions or text messages, or for technical failures of any kind, including but not limited to electronic malfunction or damage of any network, hardware or software. No responsibility is assumed for: any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, Entries; or any problems or technical malfunctions of any telephone network or lines, computer online systems, servers, providers, computer equipment, or software; or failure of any e-mail or electronic Entry to be received on account of technical problems or traffic congestion on the Internet or at any Web-site, or any combination thereof, including any injury or damage to entrant's or any other person's computer related to or resulting from participation in or downloading any materials from this Sweepstakes. In the event of a dispute over an electronic Entry, prize will be awarded to the owner of the Address or Cell, not the name on the Entry form.

#### **IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED**

On or about November 13, 2012, one (1) Grand Prize Winner (“Winner”) will be selected at random from all eligible Entries received.

Winner must meet all eligibility requirements. In the event Winner is deemed ineligible, or is not available to claim prize during specified dates, then an alternate winner will be selected at random from eligible Entries received, time permitting.

The Winner will be notified by phone on or about November 14, 2012; and will receive an Affidavit of eligibility/compliance with Rules, publicity/liability release and indemnification via mail within five (5) days of phone notification. All legal responsibilities of an entrant under the Rules will be assumed by a Parent. Winner will be required to provide satisfactory proof to Sponsor of his/her age, identity and residency. Response to mail notification must be received by Sponsor within seven (7) business days or the prize will be forfeited and may be awarded to an alternate winner, time permitting.

Any person who has won a Grand Prize from Sponsor within six months of Entry is not eligible to enter or play.

Odds of winning depend on the total number of eligible Entries received. Many will enter; only one (1) will win.

Each Canadian resident who is a potential Winner will be required to answer correctly a mathematical skill testing question without assistance of any kind whether mechanical or otherwise to be declared a winner and be eligible to collect a prize. Odds of winning depend on the total number of eligible Entries received. Federal, state and local taxes are the sole responsibility of the Winner, who, if an American, will receive an IRS Form 1099 reflecting the final value of his/her prize valued at \$600 or more. If won by a minor, prize will be awarded in parent's or guardian's name. Awarding of Prize is contingent upon Sponsor's receipt of a validly executed IRS Form W-9. Prize is subject to availability. Sponsor is not responsible for any circumstances that make it impractical or impossible to fulfill all elements of the prize; Sponsor's only obligation will be to provide the remaining elements, if any, of the prize.

## **V. PRIZE**

**ONE (1) GRAND PRIZE:** The winner ("Winner") will win a three (3) day / two (2) night trip for four (4) persons, Winner, one Parent and two other guests ("Group") to Los Angeles, CA ("City") to be at the N.B.T. Finale Concert ("Concert") and meet Ross Lynch ("Artist"). The Trip will consist of the following elements for the Group: **[1]** hotel accommodations for two (2) nights (one standard room, quadruple occupancy); **[2]** access for four (4) to the Concert; **[3]** four (4) passes to meet the Artist; **[4]**; if the Winner resides more than 250 miles from the City, round-trip coach Sponsor-selected air transportation between an airport near the Winner's residence ("airport of origin") and a Los Angeles area Airport; and **[5]** airport/hotel transfers. There are no other prizes. Winner and guests need not participate in ice-skating activities to retain all other prize elements. All expenses not specifically mentioned herein are not included and are solely the Winner's responsibility, including but not limited to: meals, alcoholic beverages, fax, gratuities and tips, insurance, laundry service, merchandise, parking, room service, service charges, souvenirs and telephone calls. Airline carrier and hotel regulations and conditions apply. Travel and lodging are subject to availability, certain restrictions, blackout dates and Sponsor's approval. **Group must travel on the same itinerary and must travel to Los Angeles, CA between December 7 – 9, 2012.** A minor (as defined by state of primary residence, "Minor") may not participate in the Trip unless accompanied by his/her Parent as a member of the Group. All members of the Group will be required to execute and return a Release of Liability prior to ticketing. Approximate retail value ("ARV"): \$4,000, which will vary depending upon point of departure and seasonal fluctuation of lodge rates and airfares. If the actual value of the prize is less than the stated ARV, the difference will not be awarded. Prize is not redeemable for cash or transferable. No substitution allowed except, at Sponsor's sole discretion, a prize of equal or greater value may be substituted. The prize cannot be used in conjunction with any other promotion or offer. Prize elements may not be separated. The prize will be awarded provided it is validly claimed by November 20, 2012, after which an alternate Winner may be selected, nor unclaimed prize awarded.

## **VI. RELEASES**

By entering this Sweepstakes and/or accepting any prize, entrants agree that: **[1]** you will be bound by these Rules and the decisions of the Sponsor, which shall be final in all respects; **[2]** you release and hold harmless the Sponsor, its parent subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees (collectively, the "Released Parties") from any and all liability for claims,

injuries, losses or damages of any kind, including without limitation, death and bodily injury, resulting, in whole or in part, directly or indirectly, from the awarding, delivery, acceptance, use, misuse, possession, loss or misdirection of any prize; participation in the Sweepstakes or any Sweepstakes-related activity or travel or from any interaction with, or downloading of, computer Sweepstakes information; [3] the Released Parties do not make any representation, warranty or guarantee, express or implied, relating to the Sweepstakes or the prize, or any ice-skating activity; [4] Winner's acceptance of a prize constitutes the grant to Sponsor and assigns of an unconditional right to use your name, voice, likeness, photograph, biographical and prize information, city and state of residence and Entry materials ("Likeness") for programming, publicity, advertising or promotional purposes, in any and all media now known or hereafter created or conceived, worldwide in perpetuity, without further compensation unless prohibited by law (Sponsor is not obligated to use any of the above mentioned information or materials, but may do so and may edit such information or materials, at Sponsor's sole discretion); [5] Winner's acceptance of prize constitutes the grant to Sponsor and assigns to discuss Likeness in programs, and Winner acknowledges that such discussion may include statements or opinions by the program talent or others about the Likeness and that those statements and opinions may be considered surprising, humiliating, embarrassing, derogatory, defamatory or otherwise offensive or injurious to them and agrees to release and hold harmless the Released Parties from any actions, claims, injury, loss or damage allegedly caused, directly or indirectly, by any such statements or opinions that may be made regarding the Likeness; [6] in the event viruses, bugs, unauthorized human intervention, Acts of God, acts or regulations of any governmental or supra-national authority, war, national emergency, accident, fire, riot, strikes, lock-outs, industrial disputes, acts of terrorism or other matters beyond the Sponsor's reasonable control, corrupt, prevent or impair the administration, security, fairness or proper play of the Sweepstakes, so that it cannot be conducted as originally planned, Sponsor has the right, in its sole discretion, to modify the Rules or to cancel, modify, terminate or suspend the Sweepstakes; and in such event, to select winners by such method as Sponsor in its sole discretion shall consider equitable; [7] the Released Parties are not responsible for typographical or other errors in the offer or administration of this Sweepstakes, including but not limited to: errors in the advertising, Rules, selection and announcement of the winners and distribution of the prizes; [8] any portion of any prize not accepted or used by any winner will be forfeited, without impact on any other prize elements; [9] the Released Parties are not responsible for any inability of any winner to accept or use any prize (or any portion thereof) for any reason; [10] the Sponsor has the right, at any time and at its sole discretion, to disqualify any individual it suspects to be doing any of the following: (a) tampering or attempting to tamper with the Entry process or the operation of the Sweepstakes; (b) violating the Rules; (c) violating the terms of service, privacy policy or other terms, conditions of use and/or general rules or guidelines of any Sweepstakes property or service; (d) acting in bad faith, unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person or (e) for any other good cause as determined solely by the Sponsor and [11] Sponsor has the right to modify prize award procedures at its sole discretion.
