#### **Disneyland® Resort- \$500 Hiring Incentive**

Attractions Busser/ Steward (Non-Tipped) Outdoor Vending Cashier

The *Disneyland*<sup>®</sup> Resort has implemented a five-hundred dollar (\$500.00) new hire incentive for select Attractions H/H, Busser/ Stewards (Non-Tipped) H/H and Outdoor Vending Cashiers H/H roles. This guideline outlines the terms and conditions for all roles that will garner the \$500 new hire incentive initiated September 16, 2007 and extending until November 10, 2007 or when appropriate staffing levels are maintained as deemed by the Company.

### **Eligible Roles**

- Attractions Host/ Hostess Roles
  - Locations: All Park Attractions locations <u>excluding Parking</u> <u>Operations, Circle D and Innoventions</u>
  - Work-statuses: Full-time (Benefited), Casual Regular (Nonbenefited), College Program & CareerStart Casual Regular (Non-benefited) <u>and excluding Casual Temporaries (Nonbenefited)</u>

# • Busser/ Steward (Non-Tipped) Host/ Hostess Roles

- Locations: All Park and Hotel food service locations
- Work-statuses: Full-time (Benefited), Casual Regular (Nonbenefited), College Program & CareerStart Casual Regular (Non-benefited) <u>and excluding Casual Temporaries (Nonbenefited)</u>

### • Outdoor Vending Cashier Host/ Hostess Roles

- Locations: All Park food cart locations
- Work-statuses: Full-time (Benefited), Casual Regular (Nonbenefited), College Program & CareerStart Casual Regular (Non-benefited) <u>and excluding Casual Temporaries (Nonbenefited)</u>

# • Hire Date Timeframe

- All *Disneyland*<sup>®</sup> Resort new hires that are hired into one of the eligible roles must have an employment start date between <u>September 16, 2007</u> and <u>November 10, 2007</u> in order to be eligible for the \$500 New Hire Incentive.
- Rehire Cast Members who have received a Hiring Bonus within 12 months of their current new hire date are ineligible for another Hiring Bonus

# Award Payout Timeframes & Eligibility

### • First \$250 Award Payment (60-days)

- All eligible new hires will receive the first incentive payment of \$250 after <u>60-days of continuous employment</u> as a *Disneyland*<sub>®</sub> Resort Cast Member in the eligible roles.
- Rehire Cast Members who have received a Hiring Bonus within 12 months of their current new hire date are ineligible for another Hiring Bonus
- This incentive payment will be included in the eligible new hire's paycheck approximately 2-3 weeks following completion of the 60-days.
- The eligible Cast Member must still be employed at the time of payment.
- This incentive payment will be taxed as income to the eligible new hire.

### • Second \$250 Incentive Payment (120-days)

- All eligible new hires will receive the second incentive payment of \$250 after <u>120-days of continuous</u> <u>employment</u> as a *Disneyland*<sup>®</sup> Resort Cast Member in the eligible roles.
- Rehire Cast Members who have received a Hiring Bonus within 12 months of their current new hire date are ineligible for another Hiring Bonus
- This incentive payment will be included in the eligible new hire's paycheck approximately 2-3 weeks following completion of the 120-days.
- The eligible Cast Member must still be employed at the time of payment.
- This incentive payment will be taxed as income to the eligible new hire.
