SWEEPSTAKES RULES

I. NAME OF SPONSOR(S)

Radio Disney, a division of ABC Radio Networks Assets, LLC (hereinafter referred to as "Radio Disney").

II. ELIGIBILITY

Entrants must be legal residents of the 50 United States (including the District of Columbia) who are physically located and residing therein (excluding Guam, Puerto Rico and all other U.S. territories and possessions) who are between the ages of 6 and 17 years of age as of date of entry.

Any individuals (including but not limited to employees, consultants, independent contractors, and interns) who have, within the past six months, performed services for Radio Disney, any organizations responsible for sponsoring, fulfilling, administering, advertising or promoting the sweepstakes or supplying the prize, and their respective parent, subsidiary, affiliated and successor companies, and immediate family and household members of such individuals, are not eligible to enter or play. "Immediate family members" shall mean parents, step-parents, children, step-children, siblings, step-siblings, or spouses. "Household members" shall mean people who share the same residence at least three months a year.

III. HOW AND WHEN TO ENTER

Go to the participating Disney's A Christmas Carol Train Tour event. Event locations and registration times can be found on the chart located at the end of this document ("Chart"). Event locations and entry times are subject to change and/or cancellation without notice.

Please visit www.ChristmasCarolTrainTour.com for the most current schedule of events and registry locations.

Obtain a Sweepstakes Entry Form on site at the event location. To participate, complete, sign and arrange for parent's and/or legal guardian's signature (if required) on Sweepstakes Entry Form. Submit completed and signed Sweepstakes Entry Form into the "Enter to Win" drawing box.

Failure to satisfactorily complete and timely submit Sweepstakes Entry Form as required herein will result in disqualification of entrant. Sweepstakes entries remain the property of Sponsors and will not be returned.

Entrant can only qualify once per market and once during the entire Train Tour "Sweepstakes Period" inclusive of events taking place from May 22 – November 1, 2009. Entries in excess of the limit by the same person will be disqualified. All required Entry Information must be completed in full. Any attempted form of entry other than as described herein is void.

IV. HOW AND WHEN WINNERS WILL BE SELECTED AND NOTIFIED

One (1) local winner ("Grand Prize Winner") from each participating Disney's A Christmas Carol Train Tour Stop will be selected.

Based on random drawing of all entries submitted at each event location for the Grand Prize, one (1) Grand Prize winner ("Grand Prize Winner") will be selected and his/her parent and/or guardian will be notified by telephone (and any additional other means deemed appropriate by Sponsor) during the specified time indicated on the Chart

below, which is subject to change. **Two attempts will be made to notify the potential winner's parent/legal guardian within the specified time period (see Chart below). Immediate response to one of the two attempted notifications must be received or the prize will be forfeited and may be awarded to an alternate winner, time permitting. Winner must be present at the event location (or nearby alternative location) within the specified time (see Chart below) or the prize will be forfeited.** If a potential Winner is found to be ineligible or he/she cannot or does not comply with these Official Rules, that potential Winner will be disqualified and another entrant may, at Sponsor's sole discretion be drawn as a Winner, as applicable, time permitting.

Approximate Retail Value of the Grand Prize is Two Hundred Fifty Four Dollars (\$254.)

At the sole discretion of the Sponsor, disqualification, forfeiture and the selection of an alternate winner may result from any of the following: (a) potential winner's failure to immediately respond to notification after two attempts; (b) potential winner's failure to be present at the train station or nearby alternate location **by** the specified time; and (c) any other non-compliance with Rules.

Failure to film Movie Surfer video will not disqualify potential winner.

Federal, state and local taxes, if any, are the sole responsibility of the Winner, who will receive a 1099 tax form reflecting actual value of any prize valued at \$600 or more.

All prizes will be awarded in parent's or guardian's name. Certain portions of the Prize are subject to availability. Grand prize is subject to change at sole discretion of sponsor.

VI. CONDITIONS OF ENTRY

By participating, entrants agree to be bound by these official rules and the decisions of the Sponsor and the administrator, which shall be final in all respects.

In addition, by participating in this sweepstakes and accepting any prize that entrant's may win, entrants agree to release Sponsors, their parent, subsidiary, affiliated and successor companies, advertising and promotion agencies and prize suppliers, and each of their respective officers, directors, agents, representatives and employees, as well as each of their respective successors, representatives and assigns (collectively, the "Released Parties") from any and all actions, claims, injury, loss or damage arising in any manner, directly or indirectly, from participation in this sweepstakes and/or acceptance or use of the prize ("Claim[s]").
