OFFICIAL SWEEPSTAKES RULES

1. HOW TO ENTER: NO PURCHASE NECESSARY. A PURCHASE DOES NOT INCREASE YOUR ODDS OF WINNING. There are four ways to enter beginning on March 1, 2007 and concluding on April 9, 2007, with the consent of a parent/guardian ("Parent"):

1.) Log on to www.clublibbylu.com or disneychannel.com/secretcelebrity and print and complete an Official Entry Form, then go to a participating Club Libby Lu retail store and drop it in the box there; OR

2.) Log on to www.clublibbylu.com or disneychannel.com/secretcelebrity and print and complete an Official Entry Form, or on a 3' x 5" piece of paper, hand-print your name, complete address, and daytime and evening telephone numbers and age, and include a Parent's signature, and mail to: Club Libby Lu "Hannah Montana Secret Celebrity Sweepstakes," 2700 West Grand Avenue, Chicago, IL 60612, OR

3.) Visit a participating Club Libby Lu retail store, complete an Official Entry Form and drop it in the box there, OR

4.) Complete an Official Entry Form received via direct mail, and either drop it in the box in a participating Club Libby Lu retail store or mail it to the address listed in #2 above.

Mailed entries must be postmarked by April 9, 2007 and received by April 13, 2007. In-Store entries must be deposited by close of business on April 9, 2007.
